KYLIE CUP SAILING INSTRUCTIONS

1. RULES

The event will be governed by the Rules For the Sport of Time Trialling 2021 Rev 2.2 by the Cruising and Power Yacht Association (CPYA), and these Sailing Instructions, which take precedence in the event of a conflict. Course, Elapsed Time and Start Time Sheets form part of these Sailing Instructions. Elapsed Time Sheets take account of mandatory speed restrictions.

2. ELIGIBILITY

Boats registered with RFBYC (Inc) and invited yacht clubs are eligible to enter this event in accordance with RFBYC (Inc) rules. All skippers must be financial members of an Australian Sailing WA affiliated yacht club, with the exception of special guest skippers who must be approved by the RFBYC Rear Commodore Power. No reason for refusal of such an entry need be given.

3. NOTICES TO COMPETITORS

Notices to competitors will be posted on the Kylie Cup event page on the RFBYC website. Kylie Cup - Royal Freshwater Bay Yacht Club (rfbyc.asn.au)

4. CHANGES IN SAILING INSTRUCTIONS

Any change in the Sailing Instructions shall be posted on the RFBYC website before 0830 hours on the day they take effect. Any changes in the schedule of events shall be posted by 1730 hours on the day before they take effect.

5. COURSE, ELAPSED TIME SHEETS, AND SAILING INSTRUCTIONS

Course, Elapsed and Start times shall be available by 1700 hours on the Thursday prior to the event.

6. JETTIES AND MOORINGS

Participating boats shall leave jetties or moorings not less than ten minutes before their start time. A boat leaving a jetty or mooring after the start and deemed by the Organising Committee to have obstructed another participating boat may incur a ten point penalty.

7. PRACTICE RUNS

Participating boats are limited to three practice runs over the start line and shall be completed before the 10 minute signal. Practice runs shall be on a course which is within six metres of East Outer Buoy.

8. BUOY IDENTIFICATION

RFBYC Start/Finish line:

An imaginary line on approximate bearing 110 magnetic drawn from the centre of the Start Box and passing through RFBYC East Buoy. Competing power yachts are to pass within 6m (when safe to do so) of RFBYC East Buoy on the side designated in the elapsed times sheet. Competing power boats will be timed on the buoy.

RFBYC South Buoy, East Buoy and North Buoys are identified as rectangular orange floats about 1m tall, which may have the letters PY painted in black on all four sides.

9. CONDUCT

A boat shall go fairly around the course, rounding or passing the series of marks on the correct side and in the correct order. If, after starting, a power yacht rounds or passes a mark on the wrong side, it shall incur a 10 point penalty in each instance that it does so.

10. POSTPONEMENT

Answering Pennant over Class Flag indicates a 60-minute postponement. Postponement may be extended indefinitely by dipping and rehoisting this signal. The Answering Pennant over the Class Flag and First Substitute indicates that the event is postponed. Both signals shall be accompanied by two sound signals.

11. RETIREMENT

The *Class Flag* should be struck and identification numbers removed immediately upon retirement from the event. The Organising Committee should be notified of the retirement as soon as possible.

12. SCORING/RESULTS

- 12.1 Boats shall compete as a single fleet.
- 12.2 The *Kylie Cup* is awarded to the boat with the Lowest Points Lost.
- 12.3 Handicap results will be announced with handicaps used for the event being those supplied by CPYA following the most recent state heat event.
- 12.4 Provisional Results will be announced as soon as possible on the day of the event. Results will be displayed on the day of the event and confirmed during the following week.
- 12.5 Times for the event will be forwarded to CPYA for the CPYA State Heat result. Scoring for this result will be in accordance with the CPYA rules for the State Time Trial Championship. 13. PROTESTS AND REDRESS

13.1 CPYA State Heat No. 7
