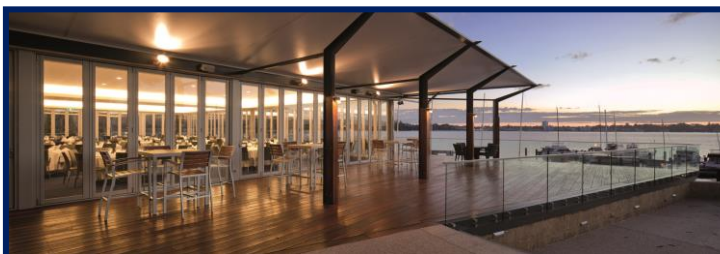

Membership – Joining Categories

Junior Under 16	Children under the age of 16.
Junior 16	Youth aged 16 and 17.
Ordinary	Members aged 18 and over. There is a tapering of fees up to the age of 36 as shown in the Fee Schedule. Ordinary members have full use of the Club, please see the Member Benefits document for a detailed explanation.
Associate	The spouse or de facto partner of a member over the age of 18 (other than a Reciprocal member).
Families	When a person joins as an Ordinary member and their spouse becomes a member as well as one or more of their children as Junior members together at the same time they are eligible for a 20% discount from the total entrance fees normally payable.
Reciprocal	Fully paid voting members of our five partner Clubs in WA may be eligible for Reciprocal membership. Conditions apply to this type of membership.
